We were assisted by Kansas City Future Orientation Unit Members Det Al Volkenrode, Det Morman, Det Shonka, Det Miller Det Bailey Det Taylor, Detective Miller Kellner, Special Const Wideman and Special Const Abold. On arrival of the residence and upon the residence front door open officers announced themselves and the warrant several times without a response. Entry was made through the open front door while continuing to announce ourselves as police officers with a warrant. The suspect was located in a bedroom and taken into custody. No other occupants could be located as the residence was left.</u></p>
