On 06-07-01, at approximately 1030 hrs., I made telephone contact with Ms. Amy McGowan. The contact was made in response to a page received from Ms. McGowan.

At that time, Ms. McGowan requested that I prepare a Statement of Probable Cause alleging Case to have murdered Anastasia WitbolsFeugen. Ms. McGowan stated Mr. Beard wanted the warrant to be issued before any contact was made between Moffett and Case.

After the documents were prepared, I contacted Ms. McGowan at her office at approximately 1240 hrs.. After she completed the necessary papers, I took the documents to Criminal Records at 1315 Locust where the documents were filed and a warrant was obtained charging Case with Murder First Degree. The warrant was then presented to Judge R. Standridge who signed the warrant and set the bond at \$200,000.00.

**PROBABLE CAUSE STATEMENT
(FELONY)**

Date: 06-07-01

I, Sgt. Gary M. Kilgore, a Deputy with the Jackson County, Missouri Sheriff's Department, upon my oath, and under penalties of perjury, state as follows:

1. I have probable cause to believe that Byron C. Case (white male 11-23-78) committed one or more criminal offenses.

MURDER FIRST DEGREE

2. The facts supporting this belief are as follows:

On 10-23-97, at approximately 0344 hrs., Jackson County Deputy Sheriff David Epperson was conducting a routine area check inside the boundaries of Lincoln Cemetery located at 8604 E. Truman Rd. in the unincorporated section of Jackson County Missouri, and found the dead body of a female, later identified as Anastasia E. Witbolsfeugen (white female 07-14-79).

Subsequent to investigation at the crime scene and the autopsy performed by Medical Examiner Dr. Thomas Young, it was determined the victim had been shot once in the face with an unknown type firearm, the projectile passed through the victims head, subsequently causing her death.

On 09-19-00, Kelly Moffet, an acquaintance of the victim, contacted Jackson County Prosecutors and informed them she was present when the victim was killed and that her then boyfriend, Byron C. Case, was the person that shot and killed Anastasia Witbolsfeugen.

According to Ms. Moffett, Justin Bruton, Byron Case and Moffett were going to get the victim when Case and Bruton began telling her they were going to kill Witbolsfeugen. Witbolsfeugen was taken to the cemetery where Ms. Moffett witnessed Byron Case shoot Witbolsfeugen in the face with a long barreled firearm.
