SUICIDE

On 10/25/97 at 1315 hours, I conducted a vehicle check on an unoccupied, green, 1997 Honda 2-door with a Missouri license plate bearing T5B 721, located near a vacant building in the 9800 blk of Sunflower Rd. The vehicle was located on the north side of the building and was facing east. Deputy Pierce #143 was with me at this time.

As I approached the vehicle, I noticed it appeared to have been sitting in this location for an extended period of time. This was due to the fact that the ground underneath the vehicle was still dry and it had been raining for the last 12 hours. Seeing there were no persons in the vehicle, I conducted a brief search of the area.

As I walked south and west, to look around the back side of the building, I observed what appeared to be a adult white male. He was laying against the building, on his back, approximately 20 to 25 feet south of the northwest corner of the building. He was wearing a grey sweatshirt, black pants and a pair of black boots. Both of his legs were extended to the west with one leg crossed over the other at the ankles.

At first, it appeared he was turned away from me, as I could not see his head. Upon closer observation, it appeared the individual had suffered a fatal gunshot wound to the head. There appeared to be no obvious signs of a struggle and the wound appeared to be consistent with a self-inflicted injury. immediately notified the Shift Sergeant, Sgt. Humerickhouse on the situation.

Deputy Pierce and I remained at the scene, checking for possible evidence. A number of photographs were taken for documentation. A black colored, twelve gauge shotgun and one spent round were found laying immediately south of the victim, next to and parallel to the victim's upper legs and torso. The shotgun was a pump-action and appeared to have one round still in the chamber. The shotgun was situated such that the tip of the barrel was located in the victim's left armpit. The spent shotgun shell was located between the butt of the shotgun and the victim's legs.

Sqt. Humerickhouse responded to the location. Deputies Brown and Grooters also responded to assist in the investigation.

Sqt. Humerickhouse conducted a computer check of the license plate of the vehicle. It was determined the vehicle was registered to Justin C. Bruton of Kansas City, Mo. HIS INFORMATION IS RESTRICTED AS TO USE AND DISSEMINATION. CIVIL AND CRIMINAL PERALTIES

Located within the victim's wallet was a Missouri drivers license. The drivers license belonged to Justin C. Bruton (w/m, dob 08/23/77). The physical identifiers on the drivers license appeared to be consistent with those of the victim. Missouri driver's license was #440885049.

At this time, the scene was handed over to Det. Atwell.
