

The following is an interview with Kelly Moffett conducted on 11/20/97 starting at approximately 1540 hours. Also present will be Kelly Moffett's mother, Debbie Moffett.

Q. Kelly, I have a couple questions before we get started. Do you know where Byron Case is right now?

A. Yeah. He's at his mom's house, down in like the Westport area, I don't know.

Q. Okay, he's not out of town, he is in town?

A. Yeah. I just talked to him like today.

Q. Have you ever known Byron to own a gun, any gun at all?

A. Hmm-mmm. No, not that I've seen.

Q. Has he ever had one in his possession that you know of?

A. No, not that I know of. Justin was the only one that had bought the gun at Wal-Mart.

Q. And do you know where that particular gun is?

A. Hmm-mmm.

Q. Had you ever seen that gun?

A. Hmm-mmm. Uh wait, yeah actually I saw it at his condo, but I mean I had never seen him fire it or anything. Cause him and Byron were arguing about, like that's stupid, it cost too much. It was just like a big toy. So.

Q. Remember what it looked like?

A. Kinda like a big BB gun. I don't know, it had that color, like on the handle and it was black.

Q. Do you know anything about guns at all?

A. Hmm-mmm.

Q. Could you tell if it was a rifle, or a shotgun, or?

A. Oh, he said it was a shotgun. Because he was like, how did you get this, like a permit for it? And he goes, aw, he goes, I just like went up there and you have to be, you

Went in SQ?

~~...don't have to be 21 to buy like a shotgun or something like that.~~

- Q. Are you aware of Justin trying to sell it in order to get money for a trip to Europe or something of this nature?
- A. Well, I knew he wanted to go to Europe, but I thought he was just going to return, like try to return it to Wal-Mart or sell it. I didn't know about anything about getting money for Europe.
- Q. Do you know if Byron disposed of the weapon for him?
- A. No, not that I know of. All I knew was that Justin didn't have the gun anymore.
- Q. Do you remember the cat that Justin had?
- A. Pagen? Yeah.
- Q. Pagen? Is there anything special about that cat?
- A. No, not that I'm, I think him and Anastasia got it from a shelter, that's all I know.
- Q. Anybody that you know of ever expressed a desire to have that cat?
- A. Yeah, Byron wanted it.
- Q. Anybody else?
- A. No. Oh, uh Tara said that she'd take it, she already has two cats and she, I think, yeah she kept Pagen at her house for a little bit when Anastasia kinda like had custody of him. But Byron just wanted it cause it was Justin's, that's all I knew.
- Q. But there was nothing special about this cat?
- A. Just a cat.
- Q. Tara McDowell. How well do you know her?
- A. Mmm, not very well. I mean, I wouldn't really consider her a friend. I don't really see her that much cause her and Byron aren't friends anymore. But probably five or six times we'd been together. We'd like go over to her apartment and stuff.
- Q. Have you talked to her since Anastasia's death?

- ~~A. Uhm, yeah. Uhm, she doesn't, her phone was off the hook,~~
so me and Byron stopped by just to tell her. And then we
also saw her like, he stopped by her different times to
tell her about the updates, cause he can't get a hold of
her through the phone.
- Q. When's the last time you saw her or talked to her?
- A. I don't remember. My friend Carol was with us, but it was
like, well like two weeks ago, probably. Other words, the
last time that I saw her was at the funeral, yeah, at
Anastasia's funeral.
- Q. Have you heard anything about who may have killed
Anastasia?
- A. Hmm-mmm, not really. Uhm, at the funeral people were like,
you know, speculating that Justin and everything. And we'd
heard like weird rumors, but that was it. Hadn't heard
like any actual like people were just kind of guessing,
like different theories. I haven't really heard anything
that anybody like actually saw it.
- Q. On the night that you and Byron and Justin picked up
Anastasia, here at this Dairy Queen, is this correct?
- A. Mmm-hmm.
- Q. What time did Justin and Byron first get over to your house
that day?
- A. Mmm, let me see. I'd been like asleep, cause I had a
headache. I don't, Mom you were gone, weren't you, like by
the time I was going to leave there? Cause they just like
showed up out of the blue. It was probably like . . .
- Mother: No, I must have been there, cause you remember
when you left I told you you had to be back?
- A. It was probably 5:30 or 6:00 No, I think . . .
- Mother: It was fairly early because I remember I told her
she's not really allowed to go out on school nights, and I
told her she had to be back by like around 9:30 or 10:00.
- Q. Okay, so you believe it was between 5:00 and 5:30?
- A. Yeah, probably. Or maybe even a little bit earlier.
Because yeah, I remember like I woke up cause I heard like
a car door slam and I looked up and I was like well, what
are they doing here? Cause it was like pretty early.

~~Q. Would that be about the right time?~~

Mother: Yeah, probably. I don't really remember, but it had to have been pretty early.

Q. And when you guys left there, where did you go?

A. Uhm, there's a I don't know, there's a gas station by my house, it's off like Quivira. What is that? 66, what is it?

Mother: On the corner of Quivira and 87th? That's a 66. Phillips 66.

A. We went there so they could get something to drink and get gas. Oh, and also Justin called Anastasia from there because their plans had been all screwed up. She's cancelled . . .

Q. About what time was this?

A. Right at probably right after they picked me up, so like 5:45 or so.

Q. And he called her from this gas station?

A. Yeah, from a pay phone there because she'd like left weird messages on his answer machine, so just to like find out what happened, he called her house, she wasn't there. Her sister Fran goes well she got a ride up to Mt. Washington. He goes well, I told her that I couldn't go and she cancelled the plans with me. And so then he's like well great, we better get back to Westport so that I can check my answering machine cause he didn't know where she was, but once he found out she was here, then he decided to go up here.

Q. And so after the gas station then you went back to Justin's apartment?

A. Mmm-hmm.

Q. About what time did you get there?

A. Mmm, 6:00, 6:30? Probably 6:30.

Q. When did you leave there?

A. Probably like 20 minutes later, so like 7:00, 7:15. Cause first he had to check all his answering, like his answer machine, and then Anastasia called from a pay phone from the Dairy Queen. And she's like get up here, I'm cold blah

~~blah blah, and they, that's when they started fighting.~~
But we didn't go right straight here. We stopped by the
tobacconist in Westport because Justin . . .

Q. You stopped by the what?

A. Tobacconist in Westport. I think it's called John
?

Q. Tobacconist.

A. They sale cigarettes and like cigars and stuff.

Q. Okay.

A. Because Justin had started smoking again and he got a pack
of cigarettes, and then we went down there to pick her up.

Q. So you left Justin's apartment at about 7:00?

A. Yeah, probably a little bit after. Yeah. We left early so
we could go to the, yeah, probably like 7:00, 7:15.

Q. And you went to where?

A. The tobacconist. It's off Pennsylvania.

Q. And then from there you went where?

A. Here.

Q. To this Dairy Queen, 24 and Winner.

A. Mmm-hmm.

Q. And do you remember about what time you got here?

A. I'd probably say 7:30, no, probably 7:45 or so. Cause it
took us a while to get down here, you know. I think Justin
was speeding, so it probably took us a half hour to get
down here. So a little bit before 8:00.

Q. And from this, when you guys, do you remember where you
parked when you pulled in here?

A. Right, cause we had to park in front so we could look in
and see her. And then we honked and she came out.

Q. Okay. Did you guys get out of the car?

A. Yeah. We did. We went inside because she was like, well
just a second. So we all got out of the car and went in.

- Q. All the way in into the building?
- A. Yeah, but just for like a few seconds.
- Q. Did you meet her outside here? She didn't come out to the car? All four of you at one point in time were inside this building?
- A. Mmm-hmm. Just for like a few seconds. We just kinda opened and looked in and Justin's like well let's go. And she was like all, she was mad and everything, so we just left. She's like, I just wanna get out of here, this place is so annoying.
- Q. Did she say that?
- A. Mmm-hmm.
- Q. And from that point where did you go first?
- A. Well she still wanted to go to Mt. Washington, so we went in there.
- Q. How did you go there?
- A. I don't really, I think we probably just went like across there. Down there. Like right into it.
- Q. That's what we're going to do, okay? Have you ever been to this cemetery before?
- A. Uh-huh. Uhm, before when I was with like Justin and Anastasia and Byron, Justin and Anastasia wanted to go here because there's one like little mausoleum thing that they think's really pretty. So we just set up there.
- Q. Did you go in this entrance right here?
- A. Yeah. The main entrance. I don't really recall the, hmm. Yeah, I think we went up that way, cause we had to make like a sharp turn and go into like a weird little woods area.
- Q. Do you remember this little bridge?
- A. Uhm, yeah. Cause at first I was kind confused. I was like, well are you sure this is Mt. Washington, cause I didn't see any like tombstone things.
- Q. Were you all just driving like this or in a hurry or anything?

- A. No, not in a hurry. Just kind of looking for a mausoleum cause that's where Anastasia wanted to like sit on the steps and talk. Cause she wanted them to be alone and then Justin was going to give me and Byron like the car, like to go drive off someplace else, well just like a little bit away and go talk, cause Anastasia's like I have to talk to you alone.
- Q. Do you know why she needed to talk to him alone?
- A. She was, well she was mad at him. I know that they had like broken up before, and she was kind of, I remember her saying something like well this is the last straw, you know, I'm freezing. You know, we've already broken up and you can't even come like pick me up on time. Stuff like that. I remember there's like a big kinda church looking thing. It's not that one, like I think it's up that way, but I'm not sure. We went past there.
- Q. Like up this way?
- A. Yeah, one of these things. I think we turned here. Cause there's like, I don't know what it is, it's just like the biggest building, like in here it like a church, and it's like in the middle and we went there because that's where Anastasia like always wanted to go.
- Q. Had you been there before?
- A. Yeah, that's where we went when I was living with them for, they went and like ate Doritos and talked and stuff like that.
- Q. Did you guys go inside it?
- A. Hmm-mmm.
- Q. Do you know if Anastasia or Justin ever went inside?
- A. No, not that I know of. I knew that there were like other mausoleums had been broken into, but I never like was with them when they went in one. I guess we went this way because there's nothing over there. I mean I don't like remember, all I remember is that building cause like the roads are so - yeah, this was it. Yeah, we went here and they was going to stop the car and get out, but there was like a load of like teenagers over there and they were . . .
- Q. Now when you pulled up in front of this, did you stop?

- ~~A. Yeah, like just kinda in the middle of the road.~~
- Q. Where?
- A. Just like along, probably this side, cause we went out that way.
- Q. Did you park the car?
- A. Yeah. Cause they started . . .
- Q. Where?
- A. Right on, like that side of the road. Like over here, kinda like on the shoulder.
- Q. Didn't pull up like on that little . . .?
- A. Hmm-mmm. We just kinda stopped here and there was like some teenagers and stuff getting out and then . . .
- Q. Where at?
- A. Uhm, right over by the steps. They were parked over by there. And then we saw a car, it looked like, I mean it wasn't like a kid's car, pull up and they started to leave, so we kinda guessed it was the caretaker. And we're like well we'd better go, cause it followed us till we left, the car did.
- W. You all got out of the car though?
- A. Mmm-hmm. Oh, well, me and Byron didn't. Him and Anastasia did. Justin and Anastasia. They kinda got out, looked over, saw the kids and saw the other car and Justin's like well, I guess that's the caretaker, we'd better go.
- Q. And they got back in the car?
- A. Mmm-hmm.
- Q. What about the other carload of kids?
- A. Just like left, too, cause they saw the caretaker, but they went out this way. And the caretaker followed us out that way.
- Q. And then which way did you go?
- A. This way.
- Q. Not that way.

- A. Yeah, right.
- Q. Not that way.
- A. Oh, that's right. Okay, we went up in there and then, oh okay, yeah. We went up in there and they Justin, Byron was like you're a moron, you can't get out that way, so we went up, it's a side way that you get on to a road. I think it might be up here. I remember going up like a weird little.
...
- Q. Do you remember which street you came out on?
- A. Mmm, just one that just like curved around. I don't think we had to make any turns or anything to go by like Erotic City.
- Q. You mean, where we came in at the Dairy Queen?
- A. It was just a road that, it came out on the side though.
- Q. But you didn't exit the same place you came in?
- A. Wait, yeah, okay yeah. We went out cause I remember we went past the caretaker's house and he stopped at the gate and he watched us till we left, and that's why we thought it was the caretaker, cause he pulled up into a little caretaker's house and we went down like a side street that kinda curved around and we were just like taking us to leave Independence cause we were going to go back to Justin's condo.
- Q. The exit that you left this cemetery, was it the same one that we entered?
- A. Yeah, cause I remember passing the caretaker's house.
- Q. Do you know if they ever went into any of the mausoleums up there?
- A. Hmm-mmm. Like, by the time we got to where we wanted to go, the caretaker pulled up. Well, I mean that night they didn't. I don't know about . . .
- Q. Not that night, any night.
- A. Uhm, maybe, I just, I think Justin knew some of the ones that were open, but when I was with them they never broke into a mausoleum.

- Q. ~~If you're concerned about being arrested or something for~~ breaking into a mausoleum, you know, I'm really not concerned with that, I'm concerned with exactly what was done that night.
- A. Hmm-mmm, no, we didn't get into any of the mausoleums, cause it was also, Anastasia was like complaining about being cold and everything like that. Huh-uh. I mean, we just, the second we saw the person we were like well it's cold, we just might as well leave.
- Q. Do you remember what she was wearing that night?
- A. Uhm yeah, cause I told her that her shirt was cute. She had on like, she always wore black jeans, mostly. Black shoes and it was like navy blue or green shirt. I think.
- Q. What about a coat?
- A. Yeah, she had on like a big floppy, I think it was brown, like weird coat. It might have been corduroy.
- Q. Did she have a purse?
- A. Huh-uh, she had a wallet though.
- Q. This will be the Truman Road entrance. You didn't go out this way did you?
- A. Well, on what road, do you know what a road like Erotic City was on?
- Q. That's Truman Road right there.
- A. Well, we came out the main entrance and then kinda curved around and went down Truman Road.
- Q. Is this the caretaker's house that you know?
- A. Yeah, I think so. Because we went by a little house.
- Q. Okay, this is the way you all exited?
- A. Mmm-hmm, I think it is. I remember as we were going out this gate, like I said the person stopped and like waited to watch us leave, so we figured it was the caretaker which obviously like wanted us out of there. I think we turned, does this run to like, yeah, we turned this way cause I remember you could see like the cemetery, most of the road.
- Q. When you left, exited, you went on Brookside.

A. Yeah.

Q. Do you remember any conversation at all that was going on between the four of you?

A. We were deciding where to go and Anastasia, her and Justin were kinda fighting back and forth, but me and Byron were just kinda in the back like having our own conversation, so they were just you know talking among themselves. She kinda seemed in a better mood though, like kinda this way. She was like laughing and stuff, but then they started getting really bad as we kinda got away from the cemetery. She was like, well I don't know where we're gonna go and talk. You always do this. Just stuff like that. Like we can never be alone. That's when he suggested that we go back to his condo.

Q. Justin suggested that.

A. Mmm-hmm.

Q. And did Anastasia agree with that?

A. Yeah. She's like well that's fine. She's like just as long as I'm not cold and we can talk. Yeah, we went this way. Right. Cause I remember passing by like over this little bridge over here.

Q. Once you got on to Truman Road then, did they continue with their arguing?

A. Mmm-hmm. Yeah.

Q. And do you remember anything at all that was said?

A. Well I remember we were also like oh, we could go in there. And she's like, that's still Washington. We were like oh well, then we might as well just go back to the condo. They were still just like fighting. I don't know, I mean it was like just the same old stuff. She was like mad that he broke up with her and she was like you're so irresponsible, you can't even come pick me up on time. We always make plans and you break 'em, stuff like that.

Q. Is that true?

A. Well, I don't know. To an extent sometimes. But she usually wanted to see him like every day, and he'd kinda get mad. He'd do like no, look you know, I promised like Byron I'd do something with him. And he also had this girl named Ashley that he was friends with, and she didn't like that. I think she also brought that up.

- Q. Does all this look familiar?
- A. Mmm-hmm, yeah. This is where they got like really bad and stuff and she was like look just take me back to my house. And he's like if you want to talk we'll talk. I didn't waste my gas money to come out here for like you to be a brat, so they kept like fighting and she's like take me home. So up at this stoplight, that was when he had to stop and she got out. He's like don't get out of the car, you're being like a baby. And then she's like look, there's two gas stations. I can't be around you right now.
- Q. So you stopped at the light right down here?
- A. Yeah, I think he was in this lane. Cause she got out and stepped on to that little thing with grass on it.
- Q. Did you continue on up over the overpass and everything, or did you turn?
- A. He came up, yeah he continued on I think. I don't remember like . . .
- Q. Okay, this is where she got out?
- A. Yeah, right at this light. I think he was thinking about like turning around like to go back and get her, but there was, I mean there really wasn't any way cause there was like traffic, so he was just like well screw it, you know, there's a gas station right by there. And she was also like, Byron was like well you know she wouldn't get back in the car if you went back to get her. And he's like . . .
- Q. About what time was that, do you remember?
- A. Uhm, not really. I don't know how long it takes to get to Westport from like Independence. But we got back to, yeah, Justin's condo like 8:15, 8:20, something like that. Cause we left his place I remember about 8:30, cause Abraham, called and wanted us to pick up some stuff of Tara's. And so Byron's like well if you have to be back by you know, 9:00 or 9:15, better go now. So we
- Q. And what time did you get home that night?
- A. Probably, well I remember looking and we were like, we're right on time. Probably, we got there a little bit before 9:00 or a little bit after. Probably a little bit after.

~~Mother: Yeah, I think I told her she had to be home by~~
like 9:15 and she got home before that.

A. Yeah, probably like 9:10.

Q. Altogether, from the time that you picked up Anastasia at Dairy Queen and the time that she got out at Truman and 435, about how much time do you think elapsed?

A. Mmm, I don't, probably, I mean like uh, like 10-15 minutes, cause well maybe a little longer than that cause we drove around the cemetery for quite a while because Justin was like all lost and everything. But it wasn't that long cause I mean, like the second we saw the caretaker, we decided we would leave and go someplace else.

Q. And after that you didn't see Anastasia again?

A. Mmm-hmm. We didn't even talk to her. We both, we were just kinda like well, she got out of the car, didn't say anything else, slammed the door, that was it.

Q. And when Justin left your house that night . . .

A. Mmm-hmm, with Byron. They were going to go drop off the stuff at Tara's.

Q. Did you ever see or talk to Justin again?

A. Mmm-hmm. I talked to Byron later that night. And then the following morning, that was when Justin called like really early.

Q. What time did you talk to Byron?

A. Probably say, I don't know, like midnight or so.

Q. How did you get in contact with Byron?

A. I paged him because we were also kind of worried about like Anastasia, because Justin had called her like from my house and then Byron had told me you know that her parents had called like Justin several times.

Q. This was about midnight?

A. Yeah. Probably like between 11:00 and midnight cause I didn't want to stay up late that night.

Q. You paged him and he called you back at your house?

A. Mmm-hmm.

Q. Where was he at?

A. His mom's house. Cause I remember he was talking about how he had to get off on-line like to call me back.

Q. What did you and Byron talk about then?

A. Just talking about like, well just the same old stuff. And then I was like, well first I was just like hey have you talked to like Anastasia? He was like no, he was like I know Justin is really upset because I think her parents have called him and also he couldn't get, I mean since we had you know stopped by his house on the way to take me home, I mean we were like pretty sure that she had like a long enough time to get home and that's when Justin like really started getting worried. When he called and talked to Fran and she still hadn't come home. So we just kind of fluctuated between like normal conversation and then we'd like you know talk about like the whole situation.

Q. Did he say anything about Justin going back out and looking for her or anything?

A. That's kinda what we specu--, well, we like speculated that because he was like well probably I should go back and look, but then I think he just decided against it. There's nothing like that that I know of. I mean he could have, but I didn't know about it. He was also, he kept saying that he was so tired he just wanted to go home and sleep.

Q. Justin?

A. Mmm-hmm.

TURNED TAPE OVER

A. He knew like the exact locations. He gave Byron directions.

Q. You say Byron got upset when they went up there?

A. Yeah, we both did. Just kinda like, well it was just like a little memorial thingy.

Q. Think like that?

A. Yeah, that's exactly what it was. It was like flowers like stuck in the ground and then a teddy bear.

Q. Do you know who set that up?

- A. ~~Hum-mm:- We thought it might be Paige Turner, but we~~ weren't sure. And then we just like thought it would be her family. Byron said he'd also heard that they were going to make like a bigger memorial, like a stone or something. Like saying something about it, but he was like you know her parents just said forget it or they like couldn't afford it. That was also one of the reasons why we went up there to see if there was like an actual monument there.
- Q. So what do you think happened?
- A. I'm really not sure. There was all these people at the funeral saying weird stuff about how they thought everybody had like a suicide pact, but I just like couldn't imagine that considering that like Justin was so apathetic and I don't think he would have. I don't know. Tara told me about like an Amoco guy that saw her walk by and how he thought that somebody had gotten her from like Erotic City, but I'm not, nothing that really makes sense. I mean I can't imagine like Justin having anything to do with it, but I can't imagine someone just like grabbing her like off, like kinda like a highway. I do know that though, Anastasia you know, at her funeral they were saying about how you know the house was going to be finished, and how she didn't think that that would happen. It just seems weird considering she was like really like melodramatic, like about the whole thing. So, but since everybody said oh this wasn't a suicide, I can't really like figure anything out.
- Q. Like a suicide. What? What did you just say?
- A. I said since people had said that it wasn't a suicide.
- Q. Oh, okay. Heard that.
- A. Mmm-hmm, heard that. I mean nobody speculated that Justin was anything other than that, but I remember at the funeral everybody was speculating on them like having a suicide pact and stuff, and then everybody was like well, you know, nobody thought Anastasia's was a suicide.
- Q. Do you think Justin killed her?
- A. I don't think so. I mean, I just couldn't imagine it. I don't think he would, like, even have time to and I just don't think he would. Like me and Byron have talked about this and he would really have like nothing to gain like over the whole thing. I mean, she kind of annoyed him, but that was like about it.

~~Q: Did Anastasia talk very much about her home life?~~

A. I remember she kind of, she got really mad at Justin once because they had this little thing on the computer, and it was like you might be white trash if. And it was like if your dad has ever, or your parents have ever willingly worked for the IRS and he sort of like kinda laughing, he's like doesn't your dad work for IRS? And she got really upset. I remember Byron telling me that he thought her mom, we kinda thought Anastasia was like a little bit co-dependent. Just because when her and Justin broke up she was always like so mad and so like upset. And I remember Byron and Justin like well telling me that her mom was married to some guy that I guess like they said he was like a drug addict and all this stuff. And they were like yeah, well she kind of seems to have gotten like the co-dependency thing from her mom. And we also knew that, she said I don't, is her name Diane? Her step-mom? They said that Anastasia, when she moved back in, she goes, her step-mom was like so not pleased that she moved back in. She didn't like, really like her that much.

Q. How about Anastasia and her father?

A. I never heard like anything bad about that. Her dad was always letting her borrow the car. That's about it. She usually only, like mentioned about her step-mom.

Q. The weekend before her death, was she with you?

A. Yeah. It was my birthday and she like came up there and took me, Byron and Carol like out.

Q. Like, where?

A. And we went around. We couldn't really like decide any place to go. It's kinda, it sounds kinda weird, but Anastasia like really you know liked cemeteries. We went to one off, let me see, Pflumm? Kinda past like 87th like a little one. And like we went up there and like sat down and talked for a while. Cause she come over pretty late and we all had to be back. Me and Carol had to be back by midnight.

Q. And what night was this?

A. Uhm, October 18. When was my birthday this year? Yeah, it was a Saturday.

Q. Do you know if anybody had access to Justin's apartment while he wasn't there?

- ~~A. When Justin wasn't there? Uhm, well I knew Byron had like a key to it, but Justin either lost it, or Justin took it back after he moved out cause he was like you know, my parents wouldn't like want somebody having a key to this, thing, but that doesn't really sound like Justin. I think he just, uh Byron lost it.~~
- Q. Do you know if Anastasia, Byron or yourself any of you guys were at Justin's apartment while Justin was out of town that weekend?
- A. No.
- Q. You were not?
- A. You mean when he went to Tulsa?
- Q. Mmm-hmm.
- A. Hmm-mmm. We weren't. I don't know about Anastasia, but I know I wasn't there. I don't know about Byron, but we weren't there. I mean I wasn't there.
- Q. Do you know if Anastasia had a key to his apartment?
- A. I don't, that was actually, she had like thrown it back at him along with like the engagement ring when they had broken up one time. So I don't think she had one. Maybe she could have like had one made. Uhm, I don't really know. She at least never mentioned it.
- Q. Did she wear very much jewelry?
- A. No. She like occasionally, I don't, no. I mean the only thing I ever saw her wear was like occasionally a little necklace or the engagement ring that Justin had given her.
- Q. And that night that you guys picked her up at Dairy Queen, did she have a purse or anything?
- A. Yeah, she had a wallet. Cause we walked in, and I think it was a wallet. She was messing with like some little like black little thing. Or like dark brown thing on the table, so I like assumed she had a wallet.
- Q. Did it look like a wallet?
- A. Yeah, mmm-hmm. It was just, yeah. I mean, I didn't like stare at it cause when we looked in and saw her she was kinda sitting there like fiddling with it. But I think that's what it was. Cause she like you know picked it up

~~-----and put it in her back pocket. So, yeah. I'm guessing it was a wallet.~~

Q. You saw her put something in her back pocket?

A. Mmm-hmm.

Q. Anything else at all about that night, that time you were with Anastasia or before or after, anything at all you can think of that I might be aware of?

A. Not really, except for the fact that I mean Anastasia was like really mad. I'd never seen her this mad. I hadn't been there when she'd like thrown stuff at him. But I mean, she was like just sitting there like kinda yelling at him with like, her teeth were like grit and everything. And I was kinda trying to like make her feel better, kinda like joking about little things, but you know, she'd laugh for a little bit, then she'd still get like really mad. So, I don't know. Me and Byron kinda speculated they'd had more of a fight earlier because I mean usually she didn't get that mad about stuff. So, I don't really know what happened earlier. They never mentioned it.
