NAME OF PERSON CONTACTED: Robert Witbolsfeugen

On 11-21-97, at approximately 0945 hrs., I was contacted by Robert Witbolsfeugen.

At this time, Mr. Witbolsfeugen stated he now remembers more about the gun Byron sold for Justin. This being the same gun that Anastasia told him about.

Mr. Witbolsfeugen stated Anastasia told him the gun had "a little, itty bitty scope on it". Anastasia had "no idea" on the size of the weapon or anything like that, according to Mr. Witbolsfeugen. Anastasia told her father the gun was a "bluish steel rifle".

Mr. Witbolsfeugen stated that Anastasia had seen the weapon at least three times and on one occasion she looked through the scope on the rifle, but did not see anything. Mr. Witbolsfeugen speculated she was inside the condo and was probably to close to any object to clearly focus.

Mr. Witbolsfeugen stated we should check ATM receipts to determine when Justin purchased the gun Anastasia saw. Mr. Witbolsfeugen believes Justin may have bought the rifle as a birthday gift for himself, or, purchased the weapon before that.


Mr. Witbolsfeugen said to me, "The previous recollection (of the shotgun) was only from my own memory. The rifle with the scope on it comes directly from Anastasia".

Mr. Witbolsfeugen stated he had a "bunch" of other things for me and when I asked the nature of his information, he began checking his notes.

Mr. Witbolsfeugen said that Abraham Kneisly is "the gun totter. He (Kneisly) is the weapons person for the cultish group".

I asked Mr. Witbolsfeugen to define "weapons person" and he stated that Kneisly has a "large personal stash of weapons".

I asked Mr. Witbolsfeugen what his source was for this information, and he told me Karen Turner. According to Mr. Witbolsfeugen, Ms.



Turner overheard a conversation between Tara McDowell and Anna Hunsicker and they were talking about Kneisly and weapons.

Mr. Witbolsfeugen stated he was concerned about Byron Case's car because Case had driven the car to Tulsa for Justin's funeral. I informed Mr. Witbolsfeugen it was my understanding that Kelly Moffett's mother drove them to Tulsa in her car.

Mr. Witbolsfeugen asked about how John Bruton was doing with his son's death and then commented that he's (Bruton) probably not satisfied with a "suicide ruling". I told Mr. Witbolsfeugen that I did not think Mr. Bruton was questioning that Justin had committed suicide.

Mr. Witbolsfeugen asked me if anyone has reported seeing Anastasia after she reportedly got out of the car. I told Mr. Witbolsfeugen that a clerk at one of the gas stations had seen a young lady that matched Anastasia's description.

Mr. Witbolsfeugen then asked if that clerk had talked to Tara McDowell. I informed Mr. Witbolsfeugen that it was my understanding that Tara had been in the area also trying to obtain information, but she has not responded to any of my messages to contact me. Therefore, I have been unable to confirm anything that Tara has done or not. Mr. Witbolsfeugen asked me if Tara was there the evening of Anastasia's death and I told him not to my knowledge.

Mr. Witbolsfeugen asked me if I had recovered the audiotape from Justin's answering machine and I informed him it was my understanding that John Bruton had recorded over the messages while he was there.

Mr. Witbolsfeugen asked me if the messages were recorded over would we be able to recover any of these messages. I told him I did not believe there was a technology to do that.

Mr. Witbolsfeugen asked that I talk to Mr. Bruton about the messages. Mr. Witbolsfeugen said there should be at least one from him when he called the condo Wednesday evening.

Mr. Witbolsfeugen speculated that Mr. Bruton knew his son was implicated and he cleaned the apartment and erased the tape. Mr. Witbolsfeugen asked me did I think Mr. Bruton would cooperate in getting the answering machine back. I believe Mr. Bruton would.

Mr. Witbolsfeugen thanked me for talking to Patrick Rock and for not disclosing any information about the case to him (Rock).

Mr. Witbolsfeugen then asked me if Rock had an "alibi" for that evening. I told Mr. Witbolsfeugen that I had not inquired about his whereabouts of that evening.

Mr. Witbolsfeugen stated Rock was a "contact" that Anastasia would call if no other ride was available. Mr. Witbolsfeugen stated Rock has had in the past a pager and Anastasia knew the number by heart.

I asked Mr. Witbolsfeugen if he suspected Patrick Rock. Mr. Witbolsfeugen stated he would suspect that Rock had contact with Anastasia sometime that night if she needed a ride, or, had to get to Kansas. Rock may have offered to take her to Justin's apartment, or, somewhere else.

Mr. Witbolsfeugen believes Anastasia returned to his house after Justin picked her up. This is based on the fact she left her billfold in the house. Mr. Witbolsfeugen believes that Anastasia returned to the house to change cloths for the evening and she must have been there between 1900 to 1930 hrs.. Mr. Witbolsfeugen asked if we had been able to confirm this and I told him I had no indication from anyone that they had went back to her house that evening.

Mr. Witbolsfeugen asked me about where Anastasia's body was found and I told him at the small circle, that she was partially in the driveway and that her head was pointed in the north direction.

Mr. Witbolsfeugen said the reason he was asking this is that he was at the cemetery "wandering around" yesterday. Mr. Witbolsfeugen looked in the direction to the south and saw a small evergreen tree with a broken branch. According to Mr. Witbolsfeugen it looked like the branch was shredded, that probably a person did not knock off the needles, but they may have been knocked off with a shotgun blast, or, a rifle shot.

Mr. Witbolsfeugen stated he also found a beer can that was "shot up" and that if we were still looking for bullets, I might try the direction straight to the south.

Mr. Witbolsfeugen is now suggesting a sniper was involved in the shooting.
