This date I responded back to this residence to talk with the above party who is the step-mother of this victim. She had taken her to Mt. Washington cemetery to meet with her exboyfriend and some of his friends. Her voluntary statement about the events are as follows:

- Q. What time did you first see Anastasia yesterday?
- A. When we brought Francesca home from school. Fran had guitar clubs yesterday so we would have arrived home about four (4) o'clock. Before four I think. Well...she got out...I got off of work around thirty-thirty (1530)...go to Lincoln to pick her up and come back here and just that travel time.
- Q. Go to Lincoln?
- A. Prep. Academy. On Woodland. It's on the way.
- Q. What was her mood at that time?
- A. Fine.
- Q. I mean she didn't seem to be having any problems at that time or anything?
- A. No. She was a..her mood was I would say even.
- Q. Did you take her somewhere later on after you got home?
- A. She..requested..me to take her to Mt. Washington Cemetery.
- Q. Did she tell you why?

- A. She was meeting her friends there.
- Q. Do you know who her friends were that she was going to meet there?
- A. Well..one of them would be..Justin. Her boyfriend. And..I got the impression that there was more than Justin. You know, maybe meet a couple of other people. Frequently when Justin would pick her up he would have some other friends with him.. And..I just assumed that that would be the same crowd of people.
- Q. So Justin wasn't there when you dropped her off?
- A. No he wasn't.
- Q. What did she say to you when she got out of the car?
- A. She didn't say anything. Well. I suppose she said thank you.
- Q. Did you talk to her after that?
- A. After .. I dropped her off?
- Q. Yes.
- A. No.
- Q. She didn't call home or anything?
- A. No. She didn't call home.
- Q. Do you recall what she was wearing when you dropped her off?
- A. She had on..her a..tan corduroy jacket..and she was wearing jeans.
- Q. What color were they?
- A. Well..I believe they were black because she customarily wore black.
- Q. Do you remember anything about her shoes?
- A. No. But her boots are here.
- Q. What about a blouse or sweater?

- A. She had her jacket on when we came in the house. And kept her jacket on. So I did not see what she was wearing.
- Q. Has she talked to you about having any problems with Justin or anything?
- A. No. She..did not..speak to me saying that she had problems. We understood that she had problems. A..but she did not approach me saying I have a problem with Justin.
- Q. Did she act like she had a problem to talk to Justin about last night when you dropped her off?
- A. When you dropped her off?
- Q. When you dropped her off at Mt. Washington Cemetery?
- A. No. I.. I got the impression that. I know it's kind of crazy for her to request to be dropped off at Mt. Washington Cemetery. Ordinarily we should have said..no. You know. That's kind of silly cause. having to be picked up at a place like that. But. when you're eighteen (18)..sometimes..and I really didn't feel.. I really didn't get the impression that a group of people who she was going to be picked up by a group of people. Including Justin. And. even though things are a little bit crazy, sometimes you have to let kids just..do their own things. And. not be to a ..adminisious. I mean by saying to them, this is not a very good idea. I didn't give her a lecture. A..
- Q. Did you and your husband have conversation last night on the phone about you told him about her leaving and about someone might not be up there to pick her up and you said something to him about letting her walk back home?
- A. Okay! I dropped Anastasia off. I think we left..to go down there to the cemetery about four-twenty (1620). Something like that. And I came back here and I went immediately to work over at my mother's house. My mother has a big renovation project..they just finished blowing insulation. I had changed into my work clothes before taking Anastasia down there. In fact, I was in such a hurry..to get over to my mom's house..and start work. That..I just complied with her wishes and didn't try to give her..you know..any argument about it. I just thought..oh the last time she asked me for a car I refused. And so I thought, okay. I won't be such a bad person and I'll just comply with her wishes and drop her off. And a..so I went immediately over to my mom's house and I was working over there and my husband phoned me..and..quizzed me about Anastasia. And I told

her that I dropped her off, I told him where I dropped her off and he told me that I was crazy and I am justifiably so I suppose. And he a..told me to go..well asked me if I would go look for her. Well..immediately after that I talked to Francesca..and..I went over..I dropped what I was doing and went over and picked up Francesca, took her over to our baby sitter's house to have Francesca's hair trimmed on the way. I drove down..to Mt. Washington Cemetery..this is about six (6) o'clock (1800). She wasn't there at the entrance. I drove around the side..oh..I drove..first I drove into the 24 Highway one because I knew that Truman Road would be backed up. Cause of the construction. And drove into the 24 Highway entrance. drove through the cemetery and went up to the gate where I dropped her off. And I saw the gates were closed..so I immediately turned around and them I got as far as the bridge and I thought..well you know she could be standing in front of the stone wall where I can't see her. So I turned around..stopped the car, went through the gates, looking and I didn't see her anywhere.

- O. What time was this now?
- A. Six O'clock (1800). So I drove back, and on my way out I looked in the bus stop. And I didn't see her in the bus stop. And I went back and picked up Francesca, brought her home and went over and worked at my mom's. Putting up insulation. Until. because my mom was. I knew my mom was taking care of..a younger child. My youngest daughter. We worked then until Bob (father) came over. What time did you come over?
- Bob. About mine (9) o'clock (2100).
- A. Around nine o'clock.
- Q. So you all haven't hand any contact since?
- A. No.
- Q. Do you feel Justin would harm her in any way?
- A. I.. I don't know Justin. I really don't know him.
- Q. Do you know of any problems she might be having with anyone else?
- A. Justin..was the whole focus. Right now Justin is the whole focus of her existence.
- Q. Have either one of you talked to Justin today?

Bob. Not today. I talked to him last night.

Q. I am going to ask you all to refrain from talking to him period during this investigation. If you don't mind. Anything else mam?

A. No.
