SGT Eitel #14 and SGT TVE #27 responded to the scene and requested the dispatcher to notify Captain Kempster of the occurrence. Captain Kempster #7 was notified along with Captain Phillips #5 and SGT Kilgore #18 of the Detective Unit. The medical Examiner's office was also notified to respond to the crime scene.

Captain Phillips and SGT Kilgore responded to the scene and took charge of evidence collecting. Doctor Boyd Harlan of the Jackson County medical Examiner's office responded to examine the body. The R/D released the scene to the detective unit and stood guard of the perimeter until relieved by Deputy Dickerson #59. The R/D then returned to service. E.O.R.
