On 09-22-00, at approximately 1005 hrs., Kelly Moffett and I left the Women's where she is residing and went back to the Independence area to travel the route they did on the evening of 10-22-97.

After arriving at the Dairy Queen, we traveled north entering the Mount Washington Cemetery. Ms. Moffett was unsure of the exact route they traveled, but after driving around the cemetery for awhile she saw the Nelson Mausoleum and recognized that to be where they briefly parked. Ms. Moffett seemed to recall Justin and Anastasia getting out of the car, but only very briefly.

Ms. Moffett was unsure of the route they took getting to the cemetery exit, but was sure they exited the same way they came in.

After exiting, Ms. Moffett recalled going south on Brookside St. and then west on Truman Rd..

As we went west on Truman, when we reached the entrance to Lincoln Cemetery, Ms. Moffett recalled this to be the way they entered. Ms. Moffett remembers the small stone house at that location.

After entering Lincoln Cemetery, Ms. Moffett was unsure of exactly where they parked and where Anastasia was shot.

Ms. Moffett was sure they exited the cemetery (after the shooting) by way of Blue Ridge Blvd.. Ms. Moffett was sure the gun was discarded after they left Lincoln Cemetery and before they went back to Justin's condo.

Ms. Moffett recalls the area where the gun was discarded. to be an industrial area or possibly near a rock quarry. We drove through areas west of Blue Ridge and then returned to the Blue Summit area and traveled west on Truman Rd. from Blue Ridge. Ms. Moffett could find no area that she remembered as being where the gun was discarded.

Ms. Moffett then recalled they left the Blue Summit area and went to a location near her residence in Lenexa. Ms. Moffett recalls that they did not drive aimlessly looking for a place to discard the gun, but it seemed to be an area that Byron and Justin were familiar with.

We then went to an area near Lake Quivera (searched the surrounding area looking for familiar sights).

This took us to an area at Inland Dr. and Douglas St.. This is where Inland Industries is located, which is a rock quarry.

On Douglas St. approximately ¼ of a mile west of Inland Dr., there is a rock/dirt road that travels to the north.

Ms. Moffett believes this to be the area the gun was discarded. Ms. Moffett believes they turned north onto this road, traveled a very short distance when the car stopped, Byron exited the vehicle and then threw the gun to the west side of the road.

Ms. Moffett was returned to the Women's Center at approximately 1325 hrs..

I returned to that location off of Douglas St. and took photographs of the area.
